# **SECTION 4: FIRST AID MEASURES**

## 4.1. <u>Description of first aid measures:</u>

### General:

## 4.2. <u>Most important symptoms and effects, both acute and delayed:</u>

#### Overview:

If material enters lungs, signs and symptoms may include coughing, choking, wheezing, difficulty in breathing, chest congestion, shortness of breath, and/or fever. The onset of respiratory symptoms may be delayed for several hours after exposure. Oil acne/folliculitis signs and symptoms may include formation of black pustules and spots on the skin of exposed areas. Ingestion may result in nausea, vomiting and/or diarrhea.
