SECTION 4: FIRST AID MEASURES

4.1. Description of first aid measures:

General:

4.2. Most important symptoms and effects, both acute and delayed:

Overview:

If material enters lungs, signs and symptoms may include coughing, choking, wheezing, difficulty in breathing, chest congestion, shortness of breath, and/or fever. 8.2. Exposure controls:

8.2.1 Appropriate engineering controls:

In pursuance of work is proper foresight needed to avoid spilling onto clothes and floors and to avoid contact with eyes and skin.
