## **SECTION 4: FIRST AID MEASURES**

#### 4.1. <u>Description of first aid measures:</u>

#### General:

# 4.2. <u>Most important symptoms and effects, both acute and delayed:</u>

### Overview:

If material enters lungs, signs and symptoms may include coughing, choking, wheezing, difficulty in breathing, chest congestion, shortness of breath, and/or fever. #### 8.2. Exposure controls:
